FREELANCE CONTRACT

This Freelance Contract (this "Agreement") is made as of this 10 day of March, 2021, (the "Effective Date") by and between Bigfork School District 38 located at 600 Commerce Street, Bigfork, MT 59911 ("Client") and GlacialEscape LLC located at 439 Grand Dr #143, Bigfork, MT 59911 ("Independent Contractor"). Client and Independent Contractor may each be referred to in this Agreement as a "Party" and collectively as the "Parties."

- 1. Services. Independent Contractor shall provide the following services to Client (the "Services"): Ondemand tech support to support district and educational needs and priorities and training of incoming technology staff. In addition, Independent Contractor shall perform such other duties and tasks, or changes to the Services, as may be agreed upon by the Parties.
- 2. Compensation. In consideration for Independent Contractor's performance of the Services, Client shall pay Independent Contractor \$60.00 per hour for up to 20 hours per month. Any additional hours worked must be pre-approved by Client. Independent Contractor will invoice client monthly on the 1st weekday of the month, for previous month's services provided, with payment due within 14 days of invoice.
- **3. Expenses.** Client shall reimburse Independent Contractor for expenses. Except as otherwise specified in this Agreement, Client shall reimburse Independent Contractor for all pre-approved, reasonable and necessary costs and expenses incurred in connection with the performance of the Services.
- **4. Term and Termination.** Independent Contractor's engagement with Client under this Agreement shall commence on March 13, 2021 and terminate on March 12, 2022. Beginning on October 1, 2021, either party may terminate this Agreement without cause by providing the other party with 30 days written notice. In lieu of notice, the Clent may terminate the Agreement immediately by paying the Independent Contractor the sume of \$1200 in addition to any amount due and owing.

At the time of termination, Independent Contractor agrees to return all Client property used in performance of the Services, including but not limited to computers, cell phones, keys, reports and other equipment and documents. Independent Contractor shall reimburse Client for any Client property lost or damaged in an amount equal to the market price of such property.

5. Independent Contractor. The Parties agree and acknowledge that Independent Contractor is an independent contractor and is not, for any purpose, an employee of Client. Independent Contractor does not have any authority to enter into agreements or contracts on behalf of Client, and shall not represent that it possesses any such authority. Independent Contractor shall not be entitled to any of Client's benefits, including, but not limited to, coverage under medical, dental, retirement or other plans. Client shall not be obligated to pay worker's compensation insurance, unemployment compensation, social security tax, withholding tax or other taxes or withholdings for or on behalf of the Independent Contractor in connection with the performance of the Services under this Agreement. Nothing contained in this Agreement shall be deemed or construed by the Parties to create the relationship of a partnership, a joint venture or any other fiduciary relationship.

6. Confidentiality.

a. Confidential and Proprietary Information. In the course of performing the Services, Independent Contractor will be exposed to confidential and proprietary information of Client. "Confidential Information" shall mean any data or information that is competitively sensitive material and not generally known to the public.

 b. Confidentiality Obligations. Except as otherwise expressly permitted in this Agreement, Independent Contractor shall not disclose or use in any manner, directly or indirectly, any Confidential Information either during the term of this Agreement or at any time thereafter, except as required to perform the Services or with Client's prior written consent. 7. Governing Law. The terms of this Agreement and the rights of the Parties hereto shall be governed exclusively by the laws of the State of Montana, without regarding its conflicts of law provisions.
