Elementary District Intent to Impose an Increase in Levies

WHEREAS, as an essential part of its budgeting process, the Board of Trustees are authorized by law to impose levies to support its budget. The Board of Trustees estimates the following increases/decreases in revenue and mills for the funds noted below for the next school fiscal year beginning July 1, 2025, using taxable valuations from the current school fiscal year as provided to the District.

BE IT RESOLVED, that the Board of Trustees of School District Number 38, Flathead & Lake Counties, Bigfork, Montana is estimating the following changes in revenues/mills to support the Elementary District budget for the 2025-26 school year:



| Transportation | \$35,000 | .69 | \$0.93 | \$1.86 |
| Bus Depreciation | \$15,000 | .29 | \$0.40 | \$0.80 |
| Tuition | \$84,000 | 1.65 | \$2.22 | \$4.44 |
| Flex | \$0 | 0 | \$0.00 | \$0.00 |
| Building Reserve | \$0 | 0 | \$0.00 | \$0.00 |
| Total | \$134,000 | 2.63 | \$3.55 | \$7.10 |


